Code of Conduct

The following behaviours will not be tolerated at the program:

- Swearing, bullying, physical aggression, theft, damage to property, unsafe behaviour (to self or others), disrespectful attitude towards staff.

The staff of Tykes and Tots School Age program will use the following guidelines when dealing with any of the above behaviours:

- 1st offense: parents verbally informed of the unacceptable behaviour.
- 2nd offense: written warning to parents.
- 3rd offense: parents will be called to immediately remove child from the program. Child will not be allowed to return to the program. Fees for the day that the child was removed will be charged. Any fees paid for future dates will be refunded to the parents within 2 weeks.

We trust that all parents will respect the guidelines of the program and encourage their children to use appropriate and respectful behavior while attending the program.
